

# Southwestern Electric Cooperative, Inc. Minutes of the Regular Meeting November 16, 2023 Greenville, IL

The regular meeting of the Board of Directors of Southwestern Electric Cooperative, Inc. was held on Thursday, November 16, 2023, at 6:30 p.m. at the office of Southwestern Electric Cooperative headquarters in Greenville, IL pursuant to notice given. President Jerry Gaffner called the meeting to order and led in the Pledge of Allegiance to the flag.

#### Approval of Minutes:

Minutes of the regular board meeting held on October 26, 2023, were considered. On a motion made by Hartlieb, seconded by Warner and carried, the minutes were approved as presented.

## **Unretired Capital Credits:**

The board reviewed the unretired capital credit totals for 1995-2022. Several topics were discussed including leveling payments, cashflow, debt, material costs, efficiencies, cost of service study, and PCA.

A motion was made by Jennings, seconded by Warner, and carried to retire the remaining 1995 unretired capital credits in the amount of \$1,002,384.22.

# 2023 Annual Write-offs of Unpaid Accounts:

The board reviewed the write-off totals for 2015-2023. There is a total of \$25,071.06 subject to write-off for 2023. After the application of unretired capital credits from members with bad debt, the adjusted total is \$5,031.06. A motion was made by Grapperhaus, seconded by Willman, and carried to write off the amount of \$25,071.06, and to immediately apply the unretired capital credits to bad debt accounts that are subject to this write-off.
